

## HOUSEHOLD HAZARDOUS WASTE COLLECTION PROJECTS

### INSTRUCTIONS:

- EVERY household must complete the Certification Liability Release form.
- Leave waste products in original containers, securely sealed.  
  
If the item is leaking or damaged:
  - place the container inside a larger sturdy container
  - seal securely
  - mark a description of the contents on the exterior container
  - unlabeled and / or non secured leaking containers will not be accepted
- NEVER combine materials in a plastic trash bag or similar container.  
Some chemicals can cause a toxic or explosive chemical reaction when mixed together.
- Separate different types of wastes into product categories, as noted on the release form.  
Items may be collected by product category at various times.
- Projects must be limited to a specific group such as a Homeowners Association or a group of employees from a specified business. NO events are to be open to the public.
- Items must be presented at the Household Hazardous Waste Facility in a single layer to be visible at time of drop off.
- Containers in excess of five gallons will not be accepted.
- Latex paint cans that have NO material left in them (no free flowing, completely dry) can be discarded in your trash with the lid off, or the metal cans can be recycled through a scrap metal service.
- NO industrial or business waste will be accepted. Only items that can normally be purchased at a store like Home Depot, Lowe's, Walmart, etc. will be accepted. No commercial or laboratory grade chemicals, cleaners, etc.
- TVs must not exceed 19" diagonal screen size.
- Items not accepted include motor oil, fluorescent lighting, tires, medications, sharps, etc.
- Any items refused by the El Paso County Household Hazardous Waste Facility will remain with the individual bringing the items and becomes their responsibility to return to original customer or dispose.
- El Paso County will provide Recycling Directories for alternative options.
