A quorum was present for the board meeting; 6:29 PM meeting called to order.

PRESIDENT CONCERNS: No new information.

COVENANT ADMINISTRATOR: Gene was absent. The tour report was emailed.

COVENANT COORDINATOR: Mark reported that the violations are slowing down. Agree to the deferral of most yard items until next spring. One home that is a rental that has not been kept in shape was issued a fining letter. Homeowner stated he would follow up and fix issues. This has not happened, so due to lateness of year, Board determined to issue a letter to homeowner stating he will be fined \$25/week from date of letter till 30 June 2022. If on 30 June the problem is fixed the fine will be eliminated, however if problem is not repaired, a lien in total amount will be placed against the home. The board has had numerous yard issues that do not get repaired and due to lateness of year keep getting rolled over to next year. This is now the board's process for those situations.
